After a discussion about the website, it was decided that Gloria would continue as the website administrator.

Terry discussed the upcoming trip to Washington, DC for Team Estonoa. They will present for the Corporation for National and Community Service and they will present their project on the National Mall. The Alumni Association made a \$500 donation toward the trip to Washington.

Judy Abbot reported on several activities happening at SPHS. She reported that the Prom had been held, students participated in sidewalk drawings as part of Earth Day activities and that the FCCLA (Family Career and Community Leaders of America) club had received several awards at the state level. (gold, 2 silver and a bronze award)

It was reported that board member Allyson Sutherland had been recognized by the Wise County School Board at their most recent meeting. Allyson was the 2009-2010 recipient of the Master Adviser Award for the FCCLA. (Family Career and Community Leaders of America)

A change of meeting date was also discussed so board meetings would not interfere with

Saint Paul Town Council meetings. It was decided by consensus that SPSHS Alumni Board meetings would be held on the 4<sup>th</sup> Monday of the quarter. After further discussion by email Suzy asked that the meetings be changed to the second Monday of the quarter (so they would not interfere with St. Paul IDA meetings).
